Eligibility Criteria

Below is an overview of eligibility criteria. No grant awards are available for project equipment that is purchased prior to completion of the fully executed contract.

Eligibility Criteria for Existing Engine:

- a. Engine must have operating hour meter.
- b. Engine must be \geq 25 horsepower.
- c. Equipment must be registered in the Air Resources Board's (ARB) Diesel Off-road On-line Reporting System (DOORS) **(Not applicable to agricultural equipment)**.
- d. Equipment must have been owned and operated in California the previous 2 years.
- e. All engines to be replaced must be in operational condition. At least 2 years documentation of usage must be included with application.
- f. Equipment / engines must have legible serial numbers.
- g. Tier 0, 1, 2, and 3 engines may be considered.
- h. Equipment must be based in Monterey, San Benito, or Santa Cruz Counties and at least 75% of the use must be in California.
- i. All existing equipment / engines replaced by the grant must be destroyed prior to reimbursement.
- j. Maximum eligible funding is **65 percent** (up to \$300,000).
