a. Reasonable notice to Air Pollution Control Officer and Petitioner.

b. 10 day notice to Air Pollution Control Officer, California Air Resources Board (CARB), US Environmental Protection Agency (US EPA), and Petitioner.

c. 30 day notice to Air Pollution Control Officer, CARB, US EPA, and Petitioner. Requires notice in at least one newspaper of general circulation.
